PRODUCT SPECIFICATION

Corrugated protection pipes black, blue, red, according to:

- BRL K536 part D: Plastics piping systems of PE-X intended for the transport of cold and heated drinking water;
- BRL K536 part E: Plastics piping systems of PE-X/Al intended transport of hot and cold drinking water;
- BRL K536 part G: Plastics piping systems of PE-RT/Al intended transport of hot and cold drinking water.

The pipe dimensions as indicated in the table below belong to this certificate.

MARKING

The products are marked with the Kiwa-mark.

Protection pipes

The minimum required marking on the protection pipes shall be:

- Kiwa (or Kiwa® word mark);
- the manufacturer's name, trade name, certificate number of the protection pipe or the certificate number of the belonging technical approval (system) certificate.

The realization of the marks is as follows: clearly and indelible at intervals of not more than 2,5 m.

LOGISTICS

Production and assembly of the system is laid down in the annex of the certification agreement.

APPLICATION AND USE

Corrugated protection pipes are compulsory for medium pipes which are not opaque in order to prevent the possible growth of algae in the medium pipe.
